## AN AMENDMENT

Regarding: Amending Article 4, Section 5c

*Whereas* pursuant to Article Sixteen, Section 1, of The Constitution of the Student Congress of Providence College: "Any active or semi-active member may propose amendments to this Constitution."

*Be it hereby enacted* by the 74th Student Congress of Providence College that the following changes be made to the Constitution:

CURRENTLY READS:

C. Two events, per semester, that embrace and appreciate diversity (such as events hosted by the Committee on Advocacy, the Stopping Homophobia, Eliminating Prejudice and Restoring Dignity (SHEPARD), and the Board of Multicultural Student Affairs (BMSA)). Events which fulfill the requirement will be at the discretion of the Executive Secretary and the chairperson of the Committee on Advocacy. This requirement may not fulfill any other service requirements

stated within The Constitution of the Student Congress. Members have one week from the event to inform the Executive Secretary of their attendance. If Members are also active in another club and are required to attend the event on the behalf of the hosting (or co-sponsoring) club or organization, the event will not fulfill the service requirement.

#### AMENDMENT STIPULATION:

C. Two **educational** events, per semester, that embrace and appreciate diversity (**including, but not limited to** events hosted by the Committee on Advocacy, the Stopping Homophobia, Eliminating Prejudice and Restoring Dignity (SHEPARD), and the Board of Multicultural Student Affairs (BMSA)). **Attendance and** events **that** fulfill the requirement will be at the discretion of the Executive Secretary, the chairperson of the Committee on Advocacy, **and the chairperson of the Subcommittee on Diversity, Equity, and Inclusion Training**. This requirement may not fulfill any other service requirements stated within the Constitution of the Student Congress **unless approved**. **The method of reporting will be up to the discretion of the Executive Secretary**. If Members are also active **members** in another club and are required to attend the event on behalf of the hosting (or co-sponsoring) club or organization, **or regularly attend club meetings**, the event **and meetings may** fulfill the service requirement.
