





Whereas pursuant to Article Sixteen, Section 1, of The Constitution of the Student Congress of Providence College: "Any active or semi-active member or subcommittee chair may propose amendments to this Constitution."

Be it hereby enacted by the 75th Student Congress of Providence College that Article 12, Section 12 of the Constitution of Student Congress be amended to include the Subcommittee on Service under Paragraph E. The Subcommittee on Service has previously been established as a standing Subcommittee of Congress; however, it is not formally placed in the Constitution.

Article 12, Section 12 Currently Reads:

There shall exist a Committee on Outreach that will facilitate interaction

between the Providence College campus and members of the Providence community through events and service opportunities.


- A. The Chair of the Committee on Outreach will act as an advisor for all other Student Congress committee or class events that involve service to the community.
- B. The Chair of the Committee on Outreach can recommend to the Executive Board of Student Congress that events that the Committee on Outreach organizes be considered mandatory for the entire Congress to attend, with the Executive Board having the final ruling.
- C. The Committee on Outreach will coordinate community wide events such as Pumpkinfest, Junior Leadership Conference (JLC), and Fusion.
- D. The Chair of the Committee on Outreach will be responsible for monitoring the community service requirement of each individual Student Congress member.
- E. The Committee on Outreach will maintain a Subcommittee on Philanthropy which will seek to facilitate participation and awareness in fundraising events for nonprofit organizations. The chair of the Subcommittee on Philanthropy will be chosen in the same manner as other chairpersons.







A. Notification will be given to the entire class via email or any communication network deemed appropriate by the Committee on Elections;


- B. The same nomination procedure outlined by Chapter One, Section One of the Standing Legislation of the Student Congress of Providence College shall be instituted;
- C. The candidates will be obliged by the restrictions, procedures, and enforcements illustrated in Chapter One, Sections Two and Four of the Standing Legislation of the Student Congress of Providence College;
- D. A date designated at the discretion of the Committee on Elections will be set to conduct the new election in accordance to the procedures established in Chapter One, Section Three of the Standing Legislation of the Student Congress of Providence College;
- E. The date of said special elections will be outlined in the "Elections Calendar" created by the Chair of the Subcommittee on Elections within the first two weeks of the academic year. This calendar is outlined it Chapter Six, Section 5, Paragraph F of the Standing Legislation;
- F. Any appeal to this process is limited to the Vice President for Student Affairs."

Whereas pursuant to Article Three, Section 1, Paragraph A of The Constitution of the Student Congress of Providence College: "The object of the Student Congress shall be to act as the official representative of the student body in order to promote meaningful student participation in the goals of Providence College consistent with the mission statement of Providence College;"

Whereas pursuant to Article Three, Section 1, Paragraph D of The Constitution of the Student Congress of Providence College: "The object of Congress shall be to promote, consistent with the Board of Trustees, the administration and the faculty, the best interests of the students of Providence College;"

Whereas pursuant to Article Three, Section 2, Paragraph B of The Constitution of the Student Congress of Providence College: "The Congress shall present all justified requests, opinions, complaints, and grievances to the appropriate official, board, or committee;"

Be it hereby recommended by the 75th Student Congress of Providence College that the college implement a policy for administering fixed out-of-class assessments per the suggested proposal:

Recommended Policy on Fixed Out-of-Class Assessments:

- Dates, times, and places for the assessments must be clearly stated in the course syllabus distributed at the start of the semester;
- For each out-of-class assessment administered, one (1) regularly scheduled class period must be canceled, unless an optional review period is held during that time. Professors may utilize asynchronous recordings to supplement material normally covered during the canceled class period.
- The responsibility falls to the student to provide the instructor with notice of their conflicts at least two (2) weeks before the assessment date;
- If there is a conflict with the scheduled assessment time, the student must work with the instructor to find a mutually acceptable time;
- If a student identifies a conflict that arises after this deadline, it is their responsibility to confer with the instructor as soon as possible about a possible makeup assessment or adjusted time;
- Student conflicts include college-related activities (e.g., clubs & organizations, athletics, rehearsals, community service, internships) and student employment;
- This policy must be readily accessible to students and faculty.

This policy applies to graded assessments including but not limited to examinations, essays, or mandatory event attendance (not including those counting for extra credit) that are administered or take place outside of the regular class time at a fixed time.

The proposed policy should be presented to the Faculty Senate following approval of Student Congress.

Whereas pursuant to Article Sixteen, Section 1, of The Constitution of the Student Congress of Providence College: "Any active or semi-active member or subcommittee chair may propose amendments to this Constitution."

Whereas pursuant to Article Three, Section 1, Paragraph A, of the Constitution of the Student Congress of Providence College: "The object of the Student Congress shall be to: act as the official representative of the student body in order to promote meaningful student participation in the goals of Providence College consistent with the mission statement of Providence College."

Be it hereby enacted by the 75th Student Congress of Providence College that an additional service requirement for Student Congress be implemented under Article 5, Section 5, Paragraph D. The amendment will read as follows:

Article 5, Section 5

D. One service event, per semester, that benefits the surrounding Providence community including, but not limited to events hosted by the Committee on Outreach (excluding Pumpkin Fest) or any campus organization that sponsors and facilitates service engagement. Events that fulfill this requirement will be at the discretion of the Chairperson of the Committee on Outreach and the Chairperson of the Subcommittee on Service. Attendance will be monitored by the Executive Secretary and the Chairperson of the Subcommittee on Service.

Be it hereby enacted by the 75th Student Congress of Providence College that the service requirement for Student Congress be monitored and overseen by the Chair of the Subcommittee on Service under Article 12, Section 12, Paragraph E. The amendment will read as follows:

Section 12, Article 12

- E. The Committee on Outreach will maintain a Subcommittee on Service, which will seek to facilitate participation in community service events both on and off campus. The chair of the Subcommittee on Service will be chosen in the same manner as other chairpersons. The role of the Chairperson of the Subcommittee on Service is outlined as follows:
 - 1. Inform members of potential service events which will fulfill the service requirement of Student Congress.
 - 2. Monitor member participation in service events and serve as the authority over all concerns regarding Article 5, Section 5, subsection D.


